Built in two sections, the earliest being the northernmost 2-bay section, to which was added a 3-bay section in 1849; dated stone in pediment of southern section. Unusually large stone quoins define the corners. On the east elevation is a full-length double-gallery porch; this porch was rebuilt to match the historic finishes including shiplap sided solid balustrade on the second floor. fenestration is flat-topped, with multi-light sash.
